Coin News from Capitol Hill:

New Dime, Quarter and Half Dollar Designs

On June 27, 2013, a bill entitled the American Liberty Coinage and Deficit Reduction Act of 2013 (HR 2535), was introduced in the US House of Representatives by Rep. Andy Barr (R-KY). It proposes that obverse designs symbolizing the concept of American liberty would appear on 40 to 50 percent of new circulating commemorative coins as soon as 2015. Remaining dimes, quarters and half dollars would continue to feature presidential portraits.

Coin reverses would also be updated, and would feature designs emblematic of patriotism, or American values such as freedom, independence, peace, strength, equality, democracy and justice. Each coin would also include the traditional obverse and reverse inscriptions, including 'LIBERTY', 'IN GOD WE TRUST', the year of minting, 'UNITED STATES OF AMERICA', 'E PLURIBUS UNUM' and the face value.

HR 2535 requires the Secretary of the Treasury to complete a study on the effects of Liberty coins on the federal budget deficit over a ten-year period. New Liberty coins would only become a reality if the study determines a reduction in the deficit of at least \$100 million.

The bill is currently being reviewed by the House Committee on Financial Services.

All designs will be considered by the Citizens Coinage Advisory Committee and finalists will be selected by the Secretary of the Treasury after consultation with the Commission of Fine Arts.

Liberty dimes and quarters would be issued by the United States Mint in alternating years, with the dime leading the change beginning in 2015. Liberty half dollars would not alternate. Fifty-cent pieces would be struck annually, and new designs would be featured every 10 years. The bill includes specific language requiring consideration of the 1977 Liberty mini dollar design that was prepared by former United States Chief Sculptor and Engraver Frank Gasparro. As shown in the accompanying picture, Gasparro proposed a flowing hair/liberty cap design for the 1979 dollar, but it was replaced by the portrait of Susan B. Anthony.



Through the U.S. Mint, bags and rolls of the dimes and quarters would be made available for numismatic purposes. Other numismatic versions would also be allowed, including proof and uncirculated Liberty coins, as well as some composed of 99.9% fine silver.
