#### GRADING BY PCI

Recently a Texas federal judge has awarded nearly \$2 million in damages o the estate of Bonnie Pereida who purchased over graded and overpriced coins from a PCA Collectibles.

The court found that PCA Collectibles misrepresented coins that were independently graded, because PCI Coin Grading company was not an independent third-party grader, as Anthony Delluniversita was the sole grader. The court explained, "Anthony purchased raw coins through PCA, personally graded the coins through PCI at no



charge to PCA, and sold the graded coins through PCA - intentionally creating the impression that the coins were graded by an independent company." The court also found systematic over grading of coins.

When Pereida died in 2011, the appointed executor and had the coins appraised for tax purposes. Heritage Auctions in Dallas conducted the initial appraisal and found the market value of the collection at the time of her death to be \$190,865. number represented just over a quarter of the amount paid (\$727,596) by Pereida. Heritage concluded that PCI over graded coins, failed to identify a counterfeit coin, and failed properly to grade improperly cleaned coins.

## Currency Trivia



#### \$500 Note

President McKinley is depicted on the front of the \$500 Federal Reserve note. The last notes delivered on July 21, 1945 to Federal Reserve Bank offices in Richmond, Kansas City, Dallas and San Francisco.



#### \$1,000 Note

President Grover Cleveland is depicted on the face of the \$1,000 Federal Reserve note. The last notes of this denomination were delivered July 21, 1945, to both the Atlanta and Kansas City Federal Reserve banks.



#### \$5,000 Note

There is a \$5,000 Federal Reserve note with the portrait of President Madison which was last recorded delivered to the St. Louis Federal Reserve Bank Oct. 18, 1943.



#### \$10,000 Note

Little known is the \$10,000 Federal Reserve note with portrait of Salmon P. Chase on the face which was last delivered July 8, 1944, to the Chicago Federal Reserve Bank.

The higher denomination paper money was primarily used for interbank transactions, authorized by an amendment to the Federal Reserve Act of 1918. The Treasury Department and Federal Reserve announced the discontinuance of notes of all four denominations July 14, 1969 due to a lack of demand as now such larger transactions tend to be made by checks, wire transfers and other means.

Notes were returned to the Federal Reserve as they were pulled from circulation and turned over to the Treasury to be destroyed.

#### The Nickel's Name is Unique

It's the only U.S. coin that is called by its metal content - even though the metal alloy in a nickel is only 25 percent nickel. The rest is copper.



# Guidelines for submitting coins for the monthly auction

When submitting coins for the monthly auction always try to use the printed club submission form. The club form lists the current submission

rules. To conserve printing costs, take one or two blank forms and make addition copies as needed. Submit individual coin in a flip or 2x2 holder. Flatten the staples of a 2x2 holder with pliers. This will protect your coins as well



as the submissions of others from damage caused by the raised staples when coins are stacked for transporting. When completing the submission form always verify the date and mint mark on your coin. Coins submitted without a reserve minimum tend to sell for higher prices than submissions with a reserve that's close to the actual value.

# Estimating the Value of Auction Lots:

Coin World values is a retail price guide for problem free coins that are nice for the grade. A coin may have the bold detail of an extremely fine (EF) coin but if it's corroded, bent, and holed, it doesn't have the value of an EF coin.

Problem coins are downgraded sometimes two or three grades depending on the severity of the problem. Some extremely rare coins, a 1793 Chain Cent for example, are expected to be found with problems and are not downgraded for minor problems. Other more common coins may be downgraded to only melt (or cull) value for severe problems. Cull coins are not appropriate for auction except in the case of a group lot with a melt value of at least \$15.00 (current club auction minimum value).

Coins may be net graded because of severe problems or may be listed at the technical grade with the problem noted. It is up to the buyer to determine what price he is willing to pay, the estimated value is the opinion of the auction chairman using Coin World values magazine.
